

**DECISION**  
**No.883, dated 13.5.2009**  
**“ON APPROVAL OF FEES FOR THE REGISTRATION OF INDUSTRIAL**  
**PROPERTY OBJECTS”, amended**

Amended by DCM:

**No. 316, dated 31.05.2018**

Pursuant to Article 100 of the Constitution and Articles 24, 25, 28, 33, 41, 44, 46, 76, 77, 79, 80, 82, 87, letters "a" - "gj", 109, 137, 149 , 172, 181,194, 198 and 202 of law no. 9947, dated 7.7.2008 "On industrial property", on the proposal of the Minister of Economy, Tourism and Energy, the Council of Ministers

**DECIDED:**

1. The fees for applications and other actions performed at the GDIP, related to patents of inventions, are according to Link no. 1, which is attached to this decision and is an integral part thereof.
2. The fees for applications and other actions performed at GDIP, related to certificates of additional protection for medicinal products and plant protection products, are according to Link no. 2, which is attached to this decision and is an integral part thereof.
3. The fees for applications and other actions performed at the GDIP, regarding the utility models, are according to Link no. 3, which is attached to this decision and is an integral part thereof.
4. The fees for applications and other actions performed at the GDIP, related to industrial designs, are according to Link no. 4, which is attached to this decision and is an integral part thereof.
5. The fees for applications and other actions performed at the GDIP, related to trademarks and service marks, are according to Link no. 5, which is attached to this decision and is an integral part thereof.
6. The fees for applications and other actions performed at the GDIP, related to geographical indications and appellations of origin, are according to Link no. 6, which is attached to this decision and forms an integral part thereof. (*it is added... "and appellations of origin", through DCM no.316, dated 31.05.2018*)
7. The fees for applications and other actions performed at the GDIP, related to integrated circuits, are according to Link no. 7, which is attached to this decision and forms an integral part thereof.
8. The fees for other services performed at GDIP are according to Link no. 8, which is attached to this decision and forms an integral part thereof.
9. The General Directorate of Industrial Property is in charge of the implementation of this decision.
10. Decision of the Council of Ministers no. 379, dated 15.08.1994 "On the fees of the patent office for industrial property objects" with subsequent amendments, is repealed. (*It is added the sentence "The Minister of Finance and the Minister of Economic Development, Trade and Entrepreneurship are tasked to issue a joint guideline to determine the directions and criteria for the use of revenues left to GDIP." Through DCM No. 37, dated 21.1. 2015*)
