An Act to repeal certain amending and repeal Acts, and for related purposes

[Assented to 11 February 2016]

The Parliament of Australia enacts:

1 Short title

This Act may be cited as the *Amending Acts 1990 to 1999 Repeal Act 2016*.

2 Commencement

- (1) Each provision of this Act specified in column 1 of the table commences, or is taken to have commenced, in accordance with column 2 of the table. Any other statement in column 2 has effect according to its terms.
