ENACTED by the Parliament of Barbados as follows:

1. This Act may be cited as the *Copyright (Amendment) Act, 2004.* Short title.

2. Section 46 of the *Copyright Act*, in this Act referred to as the principal Act, is amended

- (a) in subsection (4), by deleting
- (i) the words “\$50 000 or to imprisonment for 2 years” appearing in paragraph (a) and substituting the words “\$1 000 000 or to imprisonment for 5 years”;
  - (ii) the words “\$250 000 or to imprisonment for 5 years” appearing in paragraph (b) and substituting the words “\$500 000 or to imprisonment for 10 years”;
- (b) in subsection (5), by deleting
- (i) the words “\$25 000 or to imprisonment for 1 year” appearing in paragraph (a) and substituting the words “\$50 000 or to imprisonment for 2 years”;
  - (ii) the words “\$100 000 or to imprisonment for 3 years” appearing in paragraph (b) and substituting the words “\$200 000 or to imprisonment for 5 years”.

**3.** Section 132 of the principal Act is amended in subsection (6), by deleting

- (a) the words “\$50 000 or to imprisonment for 2 years” appearing in paragraph (a) and substituting the words “\$100 000 or to imprisonment for 5 years”; and
- (b) the words “\$250 000 or to imprisonment for 5 years” appearing in paragraph (b) and substituting the words “\$500 000 or to imprisonment for 10 years.”.

**4.** Section 134 of the principal Act is amended in subsection (2) by deleting the words “\$5 000 or to imprisonment for 6 months” and substituting the words “\$10 000 or to imprisonment for 1 year”.

- (a) subsection (1), by deleting the words “\$10 000 or to imprisonment for a term not exceeding 1 year” and substituting the words “\$20 000 or to imprisonment for 2 years”;
- (b) subsection (2), by deleting the words “\$5 000 or to imprisonment for 6 months” and substituting the words “\$10 000 or to imprisonment for 1 year.”.
