<p>Regulation of the Council of Ministers No. 233/8 November 2000, SG. 78/30.09.2005 sets out the regime for export and import of goods from/to the territory of the Republic of Bulgaria, carried out by legal entities and sole traders.</p> <p>Further, it replaces Regulation of the Council of Ministers No 271/17 December 1998, SG. 152/22.12.1998, which, in turn, repealed Regulation No. 493/23 December 1997 on the automatic licensing regime on exports of computer software on CDROM and sound and video carriers with recordings.</p>
