PLANT VARIETIES PROTECTION (AMENDMENT) ORDER, 2020

In exercise of the power conferred by Article 83(3) of the Constitution of Brunei Darussalam, His Majesty the Sultan and Yang Di-Pertuan hereby makes the following Order —

Citation and commencement

1. This Order may be cited as the Plant Varieties Protection (Amendment) Order, 2020 and shall be deemed to have commenced on 23rd April 2019.

Amendment of section 2 of S 17/2015

2. Section 2 of the Plant Varieties Protection Order, 2015, in this Order referred to as the principal Order, is amended by deleting the definition of “Minister”.

Amendment of section 16

3. Section 16 of the principal Order is amended, in subsection (3), by deleting “Minister” and by substituting “Attorney General” therefor.

Amendment of section 46

4. Section 46 of the principal Order is amended, in the definition of “authorised officer”, in paragraph (b), by deleting “Minister” from the second line and by substituting “Attorney General” therefor.

Amendment of section 47

5. Section 47 of the principal Order is amended, in subsection (5), by deleting “Minister” from the first line and by substituting “Attorney General” therefor.

Amendment of section 62

6. Section 62 of the principal Order is amended by deleting “Minister” from the first line and by substituting “Attorney General” therefor.

Amendment of section 63

7. Section 63 of the principal Order is amended, in subsection (2), by deleting “Minister” and by substituting “Attorney General” therefor.

Amendment of section 64

8. Section 64 of the principal Order is amended, in subsection (2), by deleting “Registrar may, with the approval of the Minister,” and by substituting “Attorney General may, with the approval of His Majesty the Sultan and Yang Di-Pertuan,” therefor.

Amendment of section 66

9. Section 66 of the principal Order is amended, in subsection (1), by deleting “Minister” from the first line and by substituting “Attorney General” therefor.
