Brief description of the notified legal text

Said text was proposed by the Government, first as a Provisional Act (a Decree by the President that enters into force immediately but needs to pass a vote in Parliament within 60 days lest it is considered rejected) and then, once it was aproved by the Legislative branch, as a Law. This piece of legislation amended a series of commercial laws and regulations with a view to improving the ease of doing business in Brazil. Among those amendments, the Law has rescinded two provisions of the main IP Law (9.279/1996): (i) the sole paragraph relating to Article 40, which guaranteed a post-grant minimum period for patents (10 years) and for utility models (7 years) and had to be scrapped due to a Supreme Court Decision (ADIN 5529); and (ii) Article 229-C (which in turn had been added by Law 10.196/2001, already notified), which established a need that any patent relating to pharmaceutical inventions be pre-authorized by Brazil's Sanitary Agency (Anvisa).
