1. These Administrative Instructions may be cited as the **INDUSTRIAL DESIGNS (GENERAL PROCEDURES) ADMINISTRATIVE INSTRUCTIONS, 2005.**

**RE-REGISTRATION OR RESTORATION**

Re-registration  
or restoration.

2. Where a registered industrial design has completed its fifth anniversary of registration and at least six months thereafter no application has been made to renew it, the Registrar shall allow the industrial design to be re-registered or restored on the Register, and the provisions of the Act relating to the registration of industrial designs, including the payment of the relevant fees, shall apply to such re-registration or restoration, which shall for all purposes be deemed to be a registration.
