## Brief description of the notified legal text

First notification of Executive Decree No. 34433 regulating the administrative and technical organization relating to the management, conservation and sustainable use of biodiversity, as stipulated in the Law on Biodiversity.

Executive Decree No. 34781-MINAE, of 16 July 2008, amends Article 17 of Executive Decree No. 34433.

Executive Decree No. 40043-MINAE, of 31 August 2016, repeals Article 3(b) of Executive Decree No. 34433.

Executive Decree No. 40054-MINAE, of 19 October 2016, amends Articles 20, 21, 22, 24, 31, 33 and 54 of Executive Decree No. 34433.

Executive Decree No. 40479-MINAE, of 29 June 2017, amends paragraphs VIII, IX and XI of Article 21 and Article 31 of Executive Decree No. 34433. In addition, it adds paragraph Article 22(j) to Executive Decree No. 34433.

Executive Decree No. 40725-MINAE-MICITT-MCJ, of 18 October 2017, amends the Title of Chapter IV and Articles 74 and 75 of Executive Decree No. 34433. It repeals Article 76 of Executive Decree No. 34433.

Executive Decree No. 40729-MINAE, of 19 October 2017, amends Article 12(k) and Article 17 of Executive Decree No. 34433. It repeals Article 12(p) of Executive Decree No. 34433.

Executive Decree No. 42450-MINAE, of 1 June 2020, amends Article 62 of Executive Decree No. 34433.

Executive Decree No. 42837-MINAE, of 22 January 2021, amends Article 81 of Executive Decree No. 34433.

Executive Decree No. 42742-MINAE, of 24 January 2021, adds Article 70(j) to Executive Decree No. 34433.

This is therefore a consolidated and amended version of Executive Decree No. 34433.
