Brief description of the notified legal text

The notified text regulates the procedure for access to biodiversity's genetic and biochemical materials and resources maintained in *ex situ* conditions in accordance with Article 69 of the Law on Biodiversity. It provides that any research or bioprospecting programme on biodiversity's genetic or biochemical material intended to be carried out in Costa Rican territory requires an access permit.

The Regulations apply to genetic and biochemical materials and resources of components of biodiversity, whether wild or domesticated, terrestrial, marine, freshwater or aerial, in *ex situ* conditions, located in any part of the national territory. The Regulations also apply to the protection of associated traditional knowledge and the fair and equitable sharing of benefits derived from the use of such materials and resources and/or traditional knowledge.
