The Act contains provisions and basic principles on patents. Included are provisions on patent applications and examination, licensing and transfer, termination of patent, liability to punishment and liability for damages.

It contains provisions implementing parts of Directive 2004/48/EC of the European Parliament and of the Council of 29 April 2004 on the enforcement of intellectual property rights (EU Official Journal 2004 No. L 195, p. 16); provisions implementing parts of Directive 2001/82/EC of the European Parliament and of the Council on the Community code relating to veterinary medicinal products (EC Official Journal 2001 No. L 311, p. 1) as amended by Directive 2004/28/EC (EU Official Journal 2004 No. L 136, p.58); and parts of Directive 2001/83/EC of the European Parliament and of the Council on the Community Code relating to medicinal products for human use (EC Official Journal 2001 No. L 311, p. 67) as amended by Directive 2004/27/EC (EU Official Journal 2004 No. L 136, p. 34).
