The Act contains provisions on trademarks in respect of goods or services which are the subject of registration or of an application for registration, or to which rights are acquired through use, and international registrations with validity in Denmark. It contains provisions implementing parts of Directive 2004/48/EC of the European Parliament and of the Council of 29 April 2004 on the enforcement of intellectual property rights (Official Journal of the European Union L 195 of 2 June 2004, p. 16) and Directive 2015/2436/EU of the European Parliament and of the Council of the Council of 16 December 2015 to approximate the laws of the member States relating to trademarks (Official Journal of the European Union L 336 of 23 December 2015, p.1).
