The text includes the secondary legislation of Regulation (EU) 2019/787 on spirit drinks for the part which concerns the protection of geographical indications for spirit drinks. In particular the text concerns specific rules for applications for registration (additional requirements for the single document, Member State's application dossier, admissibility of the application, national transitional period); amendments to product specifications (applications for Union amendments to product specifications, admissibility of applications for approval of Union amendments, standard amendments to product specifications, Relationship between Union and standard amendments, temporary amendments to product specifications); cancelling a geographical indication (cancellation procedure, admissibility of cancellation requests); the register and the final provisions.
