The text modifies the existing Commission Regulation (EU) No 664/2014, which is the Commission Delegated Regulation of the Regulation of the European Parliament and of the Council (EU) No 1151/2012 on Geographical Indications in the food sector, which has been amended by Regulation (EU) No 2021/2117. In particular, the text concerns specific rules for applications for approval of Union amendments and for approval and communication of standard and temporary amendments.
