The text modifies the existing Commission Regulation (EU) No 668/2014, which is the Commission Implementing Regulation of the Regulation of the European Parliament and of the Council (EU) No 2012 on Geographical Indications in the food sector, which has been amended by Regulation (EU) No 2021/2117. In particular, the text concerns specific rules for applications for approval of Union amendments and for approval and communication of standard and temporary amendments, for the use of specific digital system of managing the applications and communicating with the Commission, and for the establishment of the electronic register.
