This Order, made under section 143 of the Act, both certifies the scheme scheduled to it which is to be operated by Open University Worldwide Limited, and revokes the Copyright (Certification of Licensing Scheme for Educational Recording of Broadcasts) (Open University Educational Enterprises Limited) Order 1993 (S.I. 1993/2755) ("the 1993 Order") which it replaces. It also revokes the Copyright (Certification of Licensing Scheme for Educational Recording of Broadcasts) (Open University Educational Enterprises Limited) (Amendment) Order 1996 (S.I. 1996/190) ("the 1996 Amendment Order") which amended the 1993 Order.
