Various amendments to the Copyright, Designs and Patents Act 1988.

The Regulations implement the Directive of the European Parliament and the Council on the enforcement on intellectual property rights (Directive 2004/48/EC) ("the Enforcement Directive") and make some amendments to further implement the Agreement establishing the World Trade Organization (including the Agreement on Trade-Related Aspects of Intellectual Property Rights), the Directive of the European Parliament and of the Council on the legal protection of designs (Directive 98/71/EC), Council Regulation (EC) No. 6/2002 on Community designs and the European Economic Area Agreement.
