<p>These Regulations amend the Trade Marks Act 1994, the Trade Marks Rules 2008, the Community Trade Mark Regulations 2006 and the Trade Marks (International Registration) Order 2008 in order to transpose Directive 2015/2436 of the European Parliament and of the Council of 16 December 2015 to approximate the laws of the Member States relating to trade marks. The majority of the amendments implement those provisions of the Directive which had not already been implemented into UK law pursuant to the former Directive (Directive 2008/95/EC).</p>
