The Regulation updates references and terminology in the Trade Marks Act 1994 and the Community Trade Mark Regulations 2006 to reflect amendments to Council Regulation (EC) No 207/2009 on the European Union Trade Mark. The changes include substituting 'European Union' in place of 'Community' and replacing references to Articles of the previous repealed Regulation with references to the corresponding Articles of the EU Trade Mark Regulation.
