The Order extends to the Isle of Man provisions of the Registered Designs Act 1949, with modifications and exceptions. It revokes the Registered Designs Act 1949 (Isle of Man) Order 1989 (SI 1989/982). It also extends to the Isle of Man with modifications provisions of the Copyright, Designs and Patents Act 1988 which amended the 1949 Act, revoking and replacing so much of the Copyright, Designs and Patents Act 1988 (Isle of Man) (No. 2) Order 1989 (SI 1989/1292) and the Copyright, Designs and Patents Act 1988 (Isle of Man) Order 1990 (SI 1990/1505) as relates to those provisions.
