This Order amends the Copyright and Performances (Application to Other Countries) Order 2016 (SI 2016/2019), which, along with the Copyright, Designs and Patents Act 1988, provides copyright and rights in performances to foreign nationals. This Order extends further protections to nationals of Norway, Iceland and Liechtenstein to implement the UK's free-trade agreement with those countries.
