The Patents (General) (Amendment) Rules 2019 amends the Patents (General) Rules (Cap. 514 sub. leg. C) by specifying and regulating the necessary practices and procedures for introduction of a new "original grant" patent system and for refining the pre-existing short-term patent system, pursuant to the framework enshrined in the Patents (Amendment) Ordinance 2016.
