Brief description of the notified legal text

This notification reflects the latest changes to the Registered Designs Rules (Cap. 522A) introduced under the National Flag and National Emblem (Amendment) Ordinance 2021 (Ord. No. 31 of 2021). Specifically, section 12 of the Registered Designs Rules was amended to provide that evidence of consent to the registration of a design (on which any armorial bearings, etc. appears) is subject to the new section 8A of the Registered Designs Ordinance (Cap. 522), which prohibits the registration of a design consisting of or containing the national flag or the national emblem of the People's Republic of China or their designs.
