# PATENTS (AMENDMENT) RULES, 1980.

#### S.I. No. 186 of 1980

I, DESMOND O'MALLEY, Minister for Industry, Commerce and Tourism, in exercise of the powers conferred on me by sections 80 and 96 of the Patents Act, 1964 (No. 12 of 1964), and of the Industry, Commerce and Energy (Alteration of Name of Department and Title of Minister) Order, 1980 (S.I. No. 10 of 1980), with the sanction of the Minister for Finance, hereby make the following Rules.

1.—

- (1) These Rules may be cited as the Patents (Amendment) Rules, 1980.
- (2) These Rules shall come into operation on the 1st day of July, 1980.
- 2. The Patents Rules, 1965 (S.I. No. 268 of 1965), are hereby amended by the substitution for Schedule I (inserted by the Patents (Amendment) Rules, 1978 (S.I. No. 110 of 1978)) of the following schedule:
