PATENTS (AMENDMENT) RULES, 1986

I, MICHAEL NOONAN, Minister for Industry and Commerce, in exercise of the powers conferred on me by sections 80 and 96 of the Patents Act, 1964 (No. 12 of 1964], as adopted by the Industry, Trade, Commerce and Tourism (Alteration of Name of Department and Title of Minister) Order, 1986 (S.I. No. 41 of 1986), with the sanction of the Minister for Finance, hereby make the following Rules:

1. (1) These Rules may be cited as the Patents (Amendment) Rules, 1986.
 - (2) These Rules shall come into operation on the 1st day of April, 1986.
 - (3) The Patents Rules, 1965 to 1985, and these Rules may be cited together as the Patents Rules, 1965 to 1986.
2. The Patents Rules, 1965 (S.I. No. 268 of 1965), are hereby amended by the substitution for Schedule I (inserted by the Patents (Amendment) Rules, 1985 (S.I. No. 45 of 1985)) of the following Schedule:
