# COPYRIGHT AND RELATED RIGHTS ACT 2000 (NOTICE OF SEIZURE) REGULATIONS 2009

- I, CONOR LENIHAN, Minister of State at the Department of Enterprise, Trade and Employment, in exercise of the powers conferred on me by sections 7, 133(9), 257(9) and 338 of the Copyright and Related Rights Act 2000 (No. 28 of 2000) and the Enterprise, Trade and Employment (Delegation of Ministerial Functions) Order 2009 (S.I. No. 250 of 2009), hereby make the following regulations:
- 1. These Regulations may be cited as the Copyright and Related Rights Act 2000 (Notice of Seizure) Regulations 2009.
- 2. The form set out in the Schedule is the form prescribed for the purposes of subsections (8) and (9) of section 133 and subsections (8) and (9) of section 257 of the Copyright and Related Rights Act 2000 (No. 28 of 2000).

## **EXPLANATORY NOTE**

[This Note is not a part of the Instrument, and does not purport to be a legal interpretation]

These Regulations prescribe the form of the notice, to be given at the time of seizure, to the owner, occupier or person in charge of the place where infringing copies, illicit recordings, protection-defeating devices or articles associated with making infringing copies or illicit recordings, as the case may be, are seized under Section 133 or Section 257 of the Copyright and Related Rights Act 2000.
