<p>The principal effect of these Regulations is to provide penalties for breaches of certain provisions of Regulation (EEC) No. 1153/75 of 30 April 1975. This is, in the main, a consolidation of the provisions of Regulation (EEC) No. 1769/72 of 26 July 1972, as amended, which relates to documents to accompany consignments of wine and related products and to the records to be kept by importers, wholesalers and bottlers of wine. These Regulations also revoke the European Communities (Wine) Regulations, 1974 (S.I. No. 195 of 1974) which provided for penalties for breaches of Regulation (EEC) No. 1769/72 as amended.</p>
