This Order appoints 2 December 2019 as the day on which the Copyright and Other Intellectual Property Law Provisions Act 2019 comes into operation, in its entirety, other than sections 2(1), 9 and 21. As provided for in Section 1(7) of that Act, these sections will automatically come into operation on the date that is 6 months from the passing of the Act, which was signed by the President on 26 June 2019.
