- $\textbf{1.} \hspace{-0.1cm} \textbf{(i)} This Order may be called the International Copyright Order, 2000.$
- (ii) It shall come into force on the date of its publication in the Official Gazette.
- **2.**InthisOrder,unlessthecontextotherwi serequires.
- (a)"BerneConventionCountry"meansacountrywhichisamemberoftheBerne CopyrightUnion,andincludesacountrymentionedeitherinPartIorinPartIIofthe Schedule;
 - (b) "Phonogram" means an exclusively a ural fixation of a performance or other sounds.
- $(c) \mbox{``PhonogramsConventionCountry''} means a country which has either ratified or accepted or accepted or accepted to the Convention for the Protection or Producers of Phonograms against Unauthorized Duplication of their Phonograms, done at Geneva on the twenty-ninth day of October, one thousand nine hundred and seventy one, and includes a country mentioned in Part Vofthe Schedule;$
 - (d)"Schedule"meansthescheduleappointedtothisOrder;
- (e) "Universal Copyright Convention Country" means a country means a country mentioned either in Part III or in Part III or in Part III of the Schedule.
- (f)"WorldTradeOrganisationCountry"meansacountrywhichisamemberofth e WorldTradeOrganizationandwhichhaseitherratified,oraccepted,oraccededtothe AgreementonTradeRelatedAspectsofIntellectualPropertyRight,1994,andincludesa countrymentionedinpartVIoftheschedule.
- **3.**Subjecttotheprovisionsofparagraph4,5,6,alltheprovisionsoftheCopyright Act,1957(14of1957),(hereafterreferredtoas"theAct")exceptthoseofChapterVIII,and thoseotherprovisionswhichapplyexclusivelytoIndianworks,shallapply,
- (a)toanyworkfirstmade orpublishedinacountrymentionedinPartsI,II,III,IVor VIoftheSchedule,inlikemanner,asifitwasfirstpublishedinIndia;
- (b)toanyworkfirstmadeorpublishedinacountryotherthanacountrymentionedin PartI,II,III,IVorVIoft heschedule,theauthorofwhichwas,atthedateofsuch publication,or,wheretheauthorwasdeadonthatdate,hewasatthetimeofhisdeath,a





national of a country mentioned in Part I, II, III, IV or VI of the schedule, in like manner, as if the author was a citizen of India at that point of time.

- (c) Toanunpublishedwork, the author where of was, at the time of the making or publication of the work, anational or adomicile dinany countrymentioned in Parts I, II, III Schedule, in like manner as if the author was a citizen of, or domicile din, India.

- (e)toasoundrecordingfirstmade, the producer of which was, at the date of such production, an ational of country mentioned in Part Vorpart VI of the Schedule or abody corporate incorporate dunder a law inforce in such a country, in like manner as if the producer was the citizen of India; or abody corporate incorporate dunder a law inforce in India, as the case may be, at that point of time.
- 4. Not with standing anything contained in paragraph 3, the provisions of chapter VIII of the acts hall apply to a Broad casting Organization and aperformer in a World Trade Organization countryment ioned in part VI of the schedule.
- **5.**Notwithstandinganythingcontainedinclause (a)ofparagraph3andparagraph4the provisonsofthesub -section(1)ofsection32oftheAct —
- (i) shall not apply to a work first made or published in any Berne Convention Country mentioned in Part I of the Schedule;
- (ii)shallnotapplytoaworkfirstmadeorpublishedinanyWorl dTradeOrganization CountrymentionedinPartVIoftheSchedule;
- (iii)shallapplytoaworkfirstmadeorpublishedinanyUniversalCopyrightCountry mentionedinPartIIIorIVoftheSchedule,onlyinrespectofthetranslationofsuchwork intoany languagespecifiedintheEighthScheduletotheConstitutionofIndia.
- **6.**The provisions of sections 32 [excluding its sub -section (1)], 32 A and 32 B shall apply to a work first made or published in a Berne Convention Countrymentioned in Part I of the Schedule or in a Universal Copyright Convention Countrymentioned in Part I I of the Schedule or in a World Trade Organization Countrymentioned in Part V I of the Schedule;
- **7.**Thetermofcopyrightinaworkshallnotexceedthatwhichisenjoyedbyitin its countryoforigin.

Explanation.—Inthisparagraph, "the country of origin" shall mean

- (a)inthecaseofaworkfirstmadeorpublishedinaBerneConventionCountryora UniversalCopyrightConventionCountry,oraWorldTradeOrganisationCountry, that country;
- $(b) in the case of a work made or published simultaneously either in a Berne \\ Convention Country or a Universal Copyright Convention Country or in a World Trade$

(c) in the case of work which is made or published simultaneously in several Berne Convention Countries, the country whose laws grant the shortest rmof copyright to such a work;

(d)inthecaseofworkwhichismadeorpublishedsimultaneouslyinseveralUniversal CopyrightConventionCountries,thecountrywhoselawsgranttheshortesttermofcopyright tosuchawork;

(e)inthecaseofaworkw hichismadeorpublishedsimultaneouslyinseveralWorld TradeOrganisationCountries,thecountrywhoselawsgranttheshortesttermofcopyrightto suchawork;

(f) in case of an unpublished work or a work first made or published in a country other than a Berne Convention Country or a Universal Copyright Convention Country, or a World Trade Organisation Countries, the country or which the author was a citizen, or the country in which he was domiciled at the time of its first publication, which ever gran to the longer term of copyright.
