Brief description of the notified legal text

The consolidated version of the Industrial Property Code (Legislative Decree No. 30 of February 10, 2005) takes into account amendments up to the 'Legislative Decree No. 34 of May 19, 2020, on Urgent Measures Regarding Health, Support for Employment, and the Economy, as well as Social Policies, related to the COVID-19 Epidemiological Emergency', which entered into force on May 19, 2020.

Article 43, paragraph 6 of the said Legislative Decree repeals Article 185-ter of this consolidated version of the Industrial Property Code, relating to the enhancement of historic national brands in business crisis.
