Brief description of the notified legal text

The amendments refer to the modification of the courts' competencies, in particular providing that the litigations that fall under the ruling of the Law 50/2008 on the protection of inventions shall be dealt with by district courts, specifying that the decisions taken by the Appeal Board of the national intellectual property office (namely AGEPI), shall be challenged in the Court within whose jurisdiction AGEPI premises are located. Before this modification, the litigations regulated by the Law 50/2008 (see "Other information" below) were dealt with by the Chisinau Court of Appeal as a court of the first instance. Law No. 254/2017 provides for modifications of courts' competencies, operating amendments to 10 different legal acts. The amendment to the Law 50/2008 on protection of inventions is provided in Art. IX of Law No. 254/2017 (see "Other information" below).
