## Brief description of the notified legal text

The amendment introduced by Law 79/2018 to the Law on the protection of geographical indications, appellations of origin and traditional specialties (Law No.66/2008) provides in Art. CCV that references in Article 37 (para. 4) of Law 66/2008 to the phrase "Ministry of Agriculture and Food Industry" be replaced with the phrase "Ministry of Agriculture, Regional Development and Environment".
