IN exercise of the powers conferred by section 38A of the Trade Descriptions Act 1972, the Minister makes the following regulations:

Citation and Commencement

1. These regulations may be cited as the **Trade Descriptions (Compounding of Offences) Regulations 1994** and shall come into force on the 1st April 1994.

Compoundable Offences

2. All offences under the Act and the Trade Descriptions (Cheap Sale Price) Regulations 1987 may be compounded.

Amount of Compound Payable

3.—(1) The amount of compound payable in respect of a compoundable offence shall not exceed fifty percentum of the amount of the maximum fine that may be imposed for that offence.

(2) Where the amount specified in the offer to compound is not paid within the time specified in the offer, or any extension of it which the Controller or the Deputy Controller may grant, prosecution for the offence shall be instituted without further notice given.

Payment of Compound

4.—(1) Where an offer to compound any offence is made and accepted, payment shall be made to the Controller or the Deputy Controller in cash or by money order, postal order or banker's draft made payable to the Controller of Trade Descriptions.

(2) An official receipt for such payment shall be issued to the person to whom the offer to compound was made.



Forms for Offer to Compound and Acceptance

5.—(1) An offer to compound shall be made in Form I of the Schedule.

(2) The acceptance of the offer to compound shall be made in Form II of the Schedule.
