Revised Written Laws Act 2021

TABLE OF AMENDMENTS

The Revised Written Laws Act 2021 No 7 was certified and commenced on 1 June 2021.

An Act to bring into force the revised written laws of the Republic.

Enacted by the Parliament of Nauru as follows:

1 Short title

This Act may be cited as the *Revised Written Laws Act 2021*.

2 Commencement

This Act comes into force on certification of the Speaker and came into effect on 1 June 2021.

3 Definitions

In this Act:

‘appendices’ mean the changes effected by the Law Revision Commissioner under Section 9 of the *Law Revision and Consolidation Act 2019*, which contains the list of the written laws and universal and specific changes made to the written laws for the purposes of Section 11(2)(c);

‘specific changes’ mean the changes made to specific provisions, divisions or Parts, Schedules or prescribed forms of the written laws contained in Schedule 2; and

‘universal changes’ mean omnibus or uniform changes contained in Schedule 1 and made where necessary to all the written laws in force on the day of the certification of this Act, to bring uniformity and consistency in the written laws in accordance with Section 9 of the *Law Revision and Consolidation Act 2019*.

4 Revised Written Laws to come into force on 1st October 2021

The written laws as revised by changes contained in Schedule 1 and the list of written laws with specific changes in Schedule 2 shall come into force on the 1 October 2021.

5 Commencement of Acts to be notified

Where an Act included in the Revised Written Laws contains a provision stating that the Act or part of an Act is to come into force on a day to be nominated by a Minister:

- (a) that Act or that part of the Act shall not be deemed to be in force solely by reason of Sections 2 and 4; and
- (b) the Act or part of the Act comes into force only on the day nominated for the coming into force thereof or of that part, as provided in that Act.

6 Regulation making power

- (1) Where an Act included in the Revised Written Laws confers power to make regulations or to use prescribed forms, that power, for the purpose of making the Act or the provisions effective at the date of its coming into force, may be exercised at any time after this Act comes into force.

- (2) Any regulation or form so made or prescribed does not come into force or have effect until the Act conferring the power comes into force.

7 Enactments repealed

On 1 October 2021, all the provisions in the written laws and parts of written laws contained in Schedule 3 are repealed.

8 Repealed law not to be revived

The repeal of any written law does not:

- (a) revive such written law;
- (b) affect any savings clause in the written laws so repealed; or
- (c) prevent the application of any such written law formerly in force, to any transaction, matter or thing retrospective to the repeal.

9 References to repealed written laws

A reference in a written law enacted before the coming into force of the Revised Written Laws and remaining in force after that time or in any instrument or document, to any written law repealed under Section 7, shall, after the Revised Written Laws take effect, be deemed in respect of any subsequent transaction, matter or thing, to be a reference to the enactment in the Revised Written Laws having the same effect as the repealed written law.

10 Publication of this Act as part of the Revised Written Laws

A copy of this Act may be included in the Revised Written Laws in addition to being printed and published with the written laws enacted at the session of Parliament in which this Act is passed.

11 Schedule and appendices and publication

- (1) The Schedules to this Act are:
 - (a) Schedule 1 which contains omnibus or universal changes made to the written laws forming part of the Revised Written Laws;
 - (b) Schedule 2 which contains specific changes made to the written laws forming part of the Revised Written Laws; and
 - (c) Schedule 3 which contains the written laws which have been repealed under Section 7.
- (2) The Minister may cause to be printed and included in the Revised Written Laws:
 - (a) revised written laws contained in subsection (1);
 - (b) the *Constitution*;
 - (c) appendices prepared by the Commission listing the short titles of all the written laws in Schedules 1 and 2 under subsection (1) and such revisions and consolidations in the written laws for reference, interpretation or any other purpose;
 - (d) supplements to the Revised Written Laws; and
 - (e) any such other matter which the Minister may direct.

12 Supplements

- (1) The Commission may, under the *Law Revision and Consolidation Act*

2019, publish supplements to the Revised Written Laws as amendments or additions to the Revised Written Laws.

- (2) This Act applies to or in respect of the Revised Written Laws, with such modifications as necessary in respect of those supplements.

13 Part of Revised Written Laws

- (1) A supplement to the Revised Written Laws shall be deemed to be included in and form part of the Revised Written Laws.
- (2) The citation of any written law in the Revised Written Laws shall be deemed to include any amendments contained in the supplements.

14 Notes and tables

Any explanatory notes and tables inserted by the Commission in the Revised Written Laws form no part of those written laws and shall be deemed to have been inserted for convenience only.




15 Consequential amendment

Section 20 of the *Law Revision and Consolidation Act 2019* is amended by deleting '*Revised Written Laws of the Republic of Nauru*' and substituting with '*Revised Written Laws*'.

SCHEDULE 2

[Section 11(1)(b)]

SPECIFIC CHANGES TO THE WRITTEN LAWS

1 Accommodation Registration Act 2012

The *Accommodation Registration Act 2012* is revised as follows:

- (a) In Section 2:
 - (i) delete the word “*commences*” and substitute with “*commenced*”; and
 - (ii) insert “*and came into effect on 9 December 2020*” after ‘notice’.
- (b) In Section 7(5), delete “*in his or her discretion,*”.
- (c) In Section 21:
 - (i) in subsection (1), insert the word “*person*” after ‘another’; and
 - (ii) in subsection (2), insert the words “*the purposes of*” after ‘For’.
- (d) In Section 27(4), insert the words “*receipt of an*” after ‘On’.
- (e) In Section 28(5):
 - (i) delete “*However, the*” and substitute with “*The*”; and
 - (ii) delete the words “*of so much*”.

2 Administration of Justice Act 2018

The *Administration of Justice Act 2018* is revised as follows:

- (a) Insert the long title “*An Act to provide for the protection of the administration of justice, the dignity of the courts and for related purposes.*”
- (b) In Section 41, insert the words “*or permit to be initiated*” after ‘initiate’.

3 Administrative Arrangements Act 2011

The *Administrative Arrangements Act 2011* is revised in Section 2, by inserting “*and came into effect on 9 May 2011*” after ‘Gazette’.

4 Adoption of Children Act 1965

The *Adoption of Children Act 1965* is revised as follows:

- (a) In the long title, delete “*An Act relating to the adoption of children.*” and substitute with “*An Act to make provision for the adoption of children and for related purposes.*”.
- (b) In Section 2, delete the words “*shall come into operation on a date to be fixed by the Administrator by notice in the Gazette*” and substitute with “*came into effect on 29 March 1965*”.
- (c) In Section 3:
