Brief description of the notified legal text

This Act regulates the right of authors with respect to their works of literature, science and art (copyright), the rights of performers, producers of phonograms, film producers, broadcasting organizations, publishers and makers of databases (related rights).

This Act transposes the latest EU directives:

- Directive (EU) 2019/789 of the European Parliament and of the Council of 17 April 2019 laying down rules on the exercise of copyright and related rights applicable to certain online transmissions of broadcasting organizations and retransmissions of television and radio programmes, and amending Council Directive 93/83/EEC (OJ L 130, 17.5.2019, p. 82), except in the part relating to the collective management of copyright and related rights, and

- Directive (EU) 2019/790 of the European Parliament and of the Council of 17 April 2019 on copyright and related rights in the Digital Single Market and amending Directives 96/9/EC and 2001/29/EC (OJ L 130, 17.5.2019, p. 92), except in the part relating to the collective management of copyright and related rights.
