Having regard to decree n° 2000-1282 dated 13 June 2000, fixing the form of the official catalogue, the registration procedures of vegetable varieties and the registration conditions of the seeds and seedlings obtained recently on the waiting list,

Having regard to decree n° 2001-1802 dated 7 August 2001, fixing the amount and the methods of perception and use of the royalties due to the registration of varieties of the seeds and seedlings and certificates of vegetable obtaining at the related catalogues and of the yearly rental due on the certificates of vegetable obtaining after their registration.
