## AN ACT TO AMEND THE NAME OF GOVERNMENT MINISTRIES IN VARIOUS ACTS

I assent, GEORGE TUPOU VI, 20<sup>th</sup> July 2012.

**BE IT ENACTED** by the King and the Legislative Assembly of Tonga in the Legislature of the Kingdom as follows:

### 1 Short Title

This Act may be cited as the Miscellaneous Amendments (Name of Government Ministries) Act 2012.

### 2 Schedule 1 - Acts amended
