### Brief description of the notified legal text

"The Regulation on the Principles and Procedures Regarding the Practice of Affixing Banderols" regulates the banderol application, which is of great importance in the fight against piracy, and the activities of the provincial inspection commissions.

In terms of demand-based reproduction activities that have come to the fore in the publishing sector recently, a provision has been added to allow publishers to receive a banderol in advance and to affix the banderols they receive to the books ordered, provided that the envisaged reproduction limit is not exceeded.

Arrangements have been made regarding the working procedures and principles of the Provincial Inspection Commissions.
