## Brief description of the notified legal text

Amendments have been made in the "Regulation on the Principles and Procedures Regarding the Certification of Businesses Which Record, Reproduce and Sell or Distribute Materials Where Intellectual and Artistic Works are Fixed" to ensure their effective conduct. Within the scope of this change, the places that are subject to the certificate obligation have been rearranged, for example, places that sell fine artworks and art galleries, places that produce empty carrier materials, and film and phonogram producers are included in the certificate application.
