Brief description of the notified legal text

The Resolution approves the Procedure for requesting test samples of parental components that are constituent components of the object of a variety application, which defines the cases and appropriate procedure.

Thus, test samples of parental components of a variety may be requested by the Ministry of Agrarian Policy and Food of Ukraine in the following cases:

(1) if the Ministry of Agrarian Policy and Food of Ukraine receives a request from the competent authority of the country of variety propagation regarding compliance with the requirements of the Schemes for the Varietal Certification of Seed to which Ukraine has acceded;

(2) upon a court decision;

(3) at the request of the Ministry of Agrarian Policy and Food of Ukraine to the patent holder, and, in the absence of the patent holder, to the owner of the property right to distribute the variety or the variety maintainer regarding the need to check the safety of the variety and its original components.
