Brief description of the notified legal text

The Law repeals the Law of Ukraine "On Protection of Intellectual Property Interests of Persons during Martial Law Imposed in Connection with the Armed Aggression of the Russian Federation against Ukraine" No. 2174-IX of April 1, 2022.

The Law sets forth, in particular, the time-periods for resuming actions related to the protection of intellectual property rights, including the payment of fees for maintaining those rights and for extending the validity of a trademark certificate of Ukraine.
