Brief description of the notified legal text

Amendments to Law on Intellectual Property No. 50/2005/QH11 amended some articles in accordance with Law No. 36/2009/QH12. The amended IP Law includes 11 points of amendment/supplementation relating to patents, trademarks, geographical indications and enforcement. The amendment/supplementation aims to make the current laws and regulations comply with the Comprehensive and Progressive Agreement for Trans-Pacific Partnership (CPTPP) that took effect in Viet Nam on 14 January 2019 in which Viet Nam is one of the contract parties.
